

## PROPERTY ACCESS APPROVAL FORM

3. The granting of this permission by the undersigned is not intended, nor should it be construed to be, an admission of liability on the part of the undersigned, or the undersigned's successors, heirs, or assigns, of any liability for contamination currently existing beneath the site.
4. The undersigned shall not be liable for any injury, damage, or loss on the property suffered by CONTRACTOR, its agents, or subcontractors not caused by negligent or intentional acts of the undersigned's agents or contractors.
5. CONTRACTOR, its agents, or subcontractors will, as best as possible, repair damage to property landscape caused by its activities on the property.
6. CONTRACTOR will contact the Mississippi One-Call System, Inc. prior to any subsurface investigation or excavation, in accordance with MS Law 77-13-5.1c, and will seek information from the OWNER to minimize the risk of encountering subsurface utilities. CONTRACTOR, its agents, or subcontractors, will not be responsible for damages to subsurface utilities or structures that are not identified by the OWNER or by the Mississippi One-Call System, Inc. utilities locator contractor.
7. The Owner understands that the City of Columbus will deliver to the Owner one copy of the final test results or reports and opinions resulting from the environmental site assessment(s) performed on the property. Such copy will be provided to the Owner free of charge. The Owner further agrees that the City may make reports, including copies of any test results or opinions from the environmental site assessment, to anyone as prescribed by law, all without any liability of any type to the City or to the Contractor.
